## **ORDER**

On September 18, 2020, at 10:30 a.m., Plaintiffs' Motion for Final Approval and Motion for Attorney's Fees, Costs, and Incentive Payments came on for regularly noticed hearing. After reviewing the parties' respective submissions and allowing the parties the opportunity to be heard, the Court issued the following Orders:

- 1. The Court grants final approval of the terms of the settlement as set forth in the Revised Settlement Agreement dated March 10, 2020, and finds the terms to be fair, reasonable, adequate, and in the best interest of the class members. Defendant shall pay the gross sum of \$1,450,000 to fund the settlement of the class claims by no later than October 2, 2020.
- 2. The Court approves Class Counsel's award of attorney's fees in the amount of \$483,333 and costs in the amount of \$54,792.74 for a total amount of \$538,125.74. The award of attorney's fees and costs shall be distributed to Class Counsel by no later than October 12, 2020.
- 3. The Court approves incentive payments of \$7,500 each to Plaintiffs Erick Monroy and Ilse Ascensio for a total amount of \$15,000. The incentive payments shall be distributed to Plaintiffs by no later than October 12, 2020.
- 4. The Court approves the payment of \$50,000 to resolve the PAGA claims, 75% of which (\$37,500) shall be paid to State of California and 25% of which (\$12,500) shall be added to the distribution to the Class Members. The payment to the State of California shall be distributed no later than October 12, 2020.
- 5. The Court approves an award of administration costs in the amount of \$26,190 to the Settlement Administrator, KCC.
- 6. The Court approves the payment and distribution of the net proceeds of the settlement (\$833,184.26) to the class members who did not opt out of the Settlement. The distribution to the class member shall be made no later than October 12, 2020.
